2.4 Handing over of entire building of WIT by UTU is still pending at university level and other issues

Director and Registrar UTU were requested to get PLA money released so that the building is completed as early as possible. Additional Secretary may be approached to short out the issues.

2.5 Illegal possession of institute documents- files, students attendance Registers, library books, etc.

BOG directedthat the matter be resolved at institute level and inform Supreme Court accordingly.

2.6 Approval to conduct new contract process for the contractual faculty already on contract in the institution

The BoG advised to get posts for the faculty created/approved and then follow the procedure. Till then they may be allowed to teach as guest faculty protecting their salary.

2.7 Approval for the advertisement for the senior positions and Selection committee for the selection of institute faculty/employ after the post creation by the State Govt.

The BoG approved the advertisement for the senior positions after the creation/approval of the posts by State Govt. The reservation of the posts should be as per the cadre level. However, the same needs to be consulted with the Nyaya Vibhag of State Government.

2.8 Changes in TEQIP III Procurement and Action Plan (Revised)

The BoG approved the revised TEQIP III Procurement and Action Plan.

2.9 BOG member-Nomination

The Director of the mentor institute may be inducted in the BoG on the approval of State Government. The proposal maybe sent to the State Govt. for approval.
